(SOMEONE THAT YOU GIVE PERMISSION TO IN THE EVENT THAT YOUR PET NEEDS TO BE PICKED UP)

This agreement is between Barks 5th Avenue & the above-named pet owner . Pet Owner agrees that if his or her pet(s) are picked up **after 12:00 p.m. pet owner shall be charged for an additional day's boarding charges**. Pet Owner shall be liable for any injury or damage to Owner's pet(s) while in transit to or from Barks 5th Avenue's facility. Barks 5th Avenue may refuse to accept (or may terminate this Agreement & require pet Owner to immediately pick up) any pet(s) whose behavior could jeopardize the health or safety of Barks 5th Avenue personnel or other animals.

Upon arrival the pet(s) will be examined by Barks 5th Avenue for flea, tick & other minor health problems. If minor health problems are found, the pet(s) will be bathed or treated at pet **Owner's expense**. Pet Owner represents to Barks 5th Avenue that the **pet(s) are in good health** & that all **vaccinations, as well as a flea & tick preventative are current**. If the pet(s) becomes ill, or if the state of its health otherwise requires professional attention while in Barks 5th Avenue's care, every attempt will be made to utilize your primary veterinary . **If your veterinary clinic is unavailable, Barks 5th Avenue reserves the right to engage the services of a veterinarian of Barks 5th Avenue's choice . Charges by Barks 5th Avenue or any veterinarian for services performed shall be paid by pet Owner.**

Barks 5th Avenue shall not be liable for loss of or damage to pet owners pet(s), from any cause, including specifically but without limitation, disease, theft, fire, death, escape, or injury. In addition, Barks 5th Avenue shall not be liable for harm to person, other animals or property caused by pet Owner's pet(s) & pet Owner shall indemnify Barks 5th Avenue from any liability for any damages caused by pet Owner's pet(s)

Pet Owner's pet(s) shall be deemed abandoned if the pet Owner fails to pick up the pet(s) on the day for pick up indicated above, or if pet Owner fails to pay applicable charges. If the pet is not picked up & all charges settled by payment within seven (7) days from the date Barks 5th Avenue mails to pet Owner written notice that pet Owner's pet(s) is considered abandoned, Barks 5th Avenue may either sell the pet(s) pursuant to Barks 5th Avenue lien right or may deliver the pet(s) to a humane society as an abandoned pet(s) & Barks 5th Avenue shall have no further responsibility for the pet(s). Pet Owner shall remain liable for unpaid charges, including boarding charges until the pet(s) is sold or delivered to the humane society. In addition, pet Owner shall pay all costs & reasonable attorneys' fees & costs of collection. Pet Owner agrees to pay Barks 5th Avenue for services rendered. Any services provided by Barks 5th Avenue for which rates are not specified above shall be billed at Barks 5th Avenues standard rate schedule at the time services are rendered. Pet Owner will be billed for services pursuant to this agreement & payment is due upon receipt of the billing statement. Pet Owner will pay all of Barks 5th Avenue expenses in collection , including collection agency fees, attorney fees & cost, & other cost. Barks 5th Avenue may refuse service if billings remain unpaid charges & Barks 5th Avenue may, at its option, retain possession of pet owners pet(s) until all charges are paid.

All items must be clearly marked with pets name. Barks 5th Avenue is not responsible for any items left with your pet(s) Pet owner agrees to pay a **\$8.00 holiday sur-charge "per pet"** for the day of the following holidays: New years day, Easter, Memorial day, Independence day, Labor day, Thanksgiving & Christmas day.

BEDDING – Barks 5th Avenue provides blankets and towels for all guests. Beds or stuffed bedding that cannot be laundered using our in house equipment will not be accepted for sanitation reasons.

If Barks 5th Avenue feeds your pet while your pet(s) is boarding, (Precise Chicken Meal) owner agrees to pay \$2.00 per day. No charge if you bring your own food.

It is understood by Barks 5th Avenue & Owner that all provisions of this agreement shall be binding upon both parties here unto for this visit & for all subsequent visits, and for all pets in which pet owner owns.
