POLICY AGREEMENT

I DO HEREBY ENTRUST MY PET(S) TO BARKS 5TH AVENUE FOR THE PURPOSE OF GROOMING MY PET(S). I AM AWARE THAT ALL DUE CARE WILL BE TAKEN WITH MY PET(S) FOR THE SAFETY OF PET & GROOMER. SOMETIMES GROOMING CAN EXPOSE OR EXACERBATE A HIDDEN PRE-EXISTING CONDITION. BARKS 5TH AVENUE WILL REPORT ANY FINDINGS TO OWNER. BARKS 5TH AVENUE CANNOT DIAGNOSE A CONDITION BUT MAY ADVISE YOU TO SEEK VETERINARY ATTENTION.

IF YOUR PET(S) HAS ANY MEDICAL PROBLEMS, BARKS 5TH AVENUE ASKS TO BE MADE AWARE OF THEM SO THAT THE GROOMER MAY TAKE ANY NECESSARY PRECAUTIONS NEEDED TO MAKE YOUR PET COMFORTABLE.

I AM AWARE THAT NEGLECT OF MY PET'S COAT CAN POTENTIALLY CAUSE PROBLEMS AFTER GROOMING, SUCH AS CLIPPER/BRUSH IRRITATION. IF MY PET IS UNCOOPERATIVE OR DOES NOT REMAIN STILL DURING THE GROOMING PROCEDURE, ACCIDENTS CAN HAPPEN SUCH AS NICKS FROM CLIPPERS OR SCISSORS. I

AM AWARE THAT IF MY PET'S COAT IS MATTED MY OPTIONS ARE:

A. DE-MAT AT \$1.00 PER MINUTE IN ADDITION TO THE REGULAR GROOM FEE, NOT TO EXCEED 30 MIN. FOR THE COMFORT OF PET.

B. A COMPLETE SHAVE DOWN (a mat charge may apply, depending on the severity)

PAYMENT

PAYMENT IS DUE WHEN SERVICES ARE RENDERED. WE ACCEPT CASH, CHECK, VISA, MASTERCARD, & DISCOVER. A \$25.00 FEE FOR ANY NON-SUFFICIENT CHECKS. BARKS 5TH AVENUE HAS THE RIGHT TO REFUSE SERVICE. IN THE EVENT THAT THE GROOMER CAN NOT SAFELY HANDLE YOUR PET DUE TO BEHAVIOR, GROOMING SERVICES CAN BE STOPPED MID-GROOM IF NECESSARY FOR THE SAFETY OF THE PET &/OR GROOMER, AND I UNDERSTAND THAT I WILL PAY A MINIMUM \$25.00 HANDLING FEE
